



## Drug Related Offences & Seizures, 1998 - 2006

In WA over the nine year period 1998 to 2006 there were about 3,500 to 4,000 drug offences per quarter, of which about 85% involved possession (ie minor) drug offences. There were a number of notable trends in seizures in relation to cannabis, amphetamines, heroin and ecstasy. In relation to all drug seizures, the annual number and proportion of cannabis seizures decreased from 16,798 (84.2%) seizures in 1998 to 9,911 (64.3%) seizures in 2006, whereas amphetamine seizures sharply increased from 1,019 (5.1%) in 1998 to 3,404 (22.1%) in 2006. With respect to heroin, seizures steadily declined from 852 (4.3%) seizures in 1998 to 131 (1.0%) seizures in 2006 and seizures involving ecstasy (MDMA) increased from 190 (1.0%) seizures in 1998 to 482 (3.1%) seizures in 2006.

### Drug Offences: 1998-2006

From the March quarter 1998 up to the present there were about 3,500 to 4,000 drug offences per quarter, of which about 85% were 'possession' offences (ie possession/use of drugs and possession of implements), with the remaining 15% being 'trafficking' offences (ie sell/supply, cultivation and manufacture).

All offences increased from the March quarter 1998 (3,047 offences) to the June quarter 2001 (4,145 offences), declined to the December quarter 2003 (2,808 offences), then increased to 4,508 in the September quarter 2006 and dropped to 3,768 in the December quarter 2006 (Figure 1).

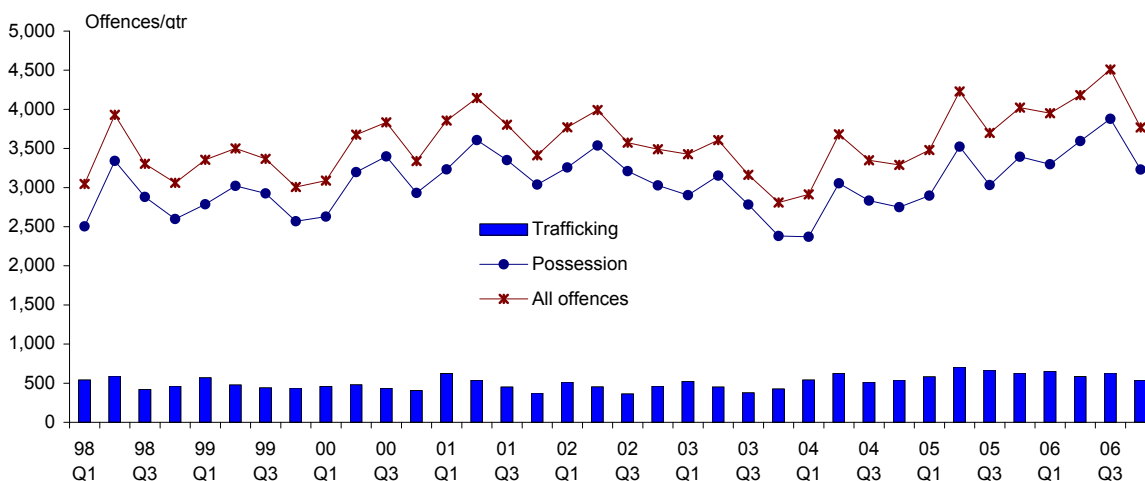
The annual trends in drug offences in Table 1 (page 2) show that 'possession' offences increased from 11,324 in 1998 to 13,229 in 2001, then declined to 11,009 in 2004 and increased again, to 14,000 in 2006. Throughout most of the nine year period about 15% of all offences were trafficking offences, except between 2000 and 2003 when there was a small decline in the overall proportion of trafficking offences.

### Police Regions & Districts: 2000-2006

*Note: A breakdown of offences at a regional level is available from the September quarter 2000, when the present system of regional boundaries was introduced.*

The majority of drug offences occurred in the Metropolitan Region, accounting for about two thirds of all drug offences in the State.

In the December quarter 2006 there was a total of 3,527 processed persons charged with drug offences, of whom 2,416 (68.5%) were in the Metropolitan Region, 577 (16.4%) were in the Southern Region and 534 (15.1%) were in the North East Region.

A breakdown of quarterly offences by age group, which is based on *processed persons*, shows that about three quarters of all drug offences involved persons aged between 15 and 34 years.

In the December quarter 2006, there was a total of 3,527 processed persons, of whom:

- 54 (1.5%) were aged less than 15 years;
- 667 (18.9%) were aged 15 to 19 years;
- 730 (20.7%) were aged 20 to 24 years;
- 1,128 (32.0%) were aged 25 to 34 years;
- 670 (19.0%) were aged 35 to 44 years; and
- 278 (7.9%) were aged 45 years and older.

## Metropolitan Region: 2006

In the December quarter 2006 there was a total of 2,416 processed persons in the Metropolitan Region charged with drug offences, which by Police District (PD) were:

- South East Metro - 547 (22.6%);
- South Metro - 537 (22.2%);
- North West Metro - 290 (12.0%);
- East Metro - 330 (13.7%);
- West Metro - 286 (11.8%); and
- Central Metro - 426 (17.6%).

In the year 2006 there was a total of 11,404 offences, of which 9,786 (85.8%) were possession offences and 1,618 (14.2%) were trafficking offences.

A breakdown of data for the Metropolitan Region by age group, which is counted on *processed persons*, shows about three quarters of all drug offences involved persons aged between 15 and 34 years. In 2006 there was a total of 10,511 processed persons (excluding cases where age is not known), of whom:

- 140 (1.3%) were aged less than 15 years;
- 2,053 (19.5%) were aged 15 to 19 years;
- 2,484 (23.6%) were aged 20 to 24 years;
- 3,281 (31.2%) were aged 25 to 34 years;
- 1,892 (18.0%) were aged 35 to 44 years; and
- 661 (6.3%) were aged 45 years and older.

## Southern Region: 2006

In the December quarter 2006 there was a total of 577 processed persons in the Southern Region charged with drug offences, which by PD were:

- Great Southern - 185 (32.1%);
- Peel - 89 (15.4%);
- South West - 196 (34.0%); and
- Wheatbelt - 107 (18.5%).

In the year 2006 there was a total of 2,847 offences, of which 2,386 (83.8%) were possession offences and 461 (16.2%) were trafficking offences.

A breakdown of data for the Southern Region by age group, which is counted on *processed persons*, shows that about seven out of 10 of all drug offences involved persons aged between 15 and 34 years.

In the year 2006 there was a total of 2,593 processed persons (excluding cases where age is not known), of whom:

- 88 (3.4%) were aged less than 15 years;
- 496 (19.1%) were aged 15 to 19 years;
- 460 (17.7%) were aged 20 to 24 years;
- 757 (29.2%) were aged 25 to 34 years;
- 548 (21.1%) were aged 35 to 44 years; and
- 244 (9.4%) were aged 45 years and older.

### North East Region: 2006

In the December quarter 2006 there was a total of 534 processed persons in the North East Region charged with drug offences, which by PD were:

- Goldfields-Esperance - 204 (38.2%);
- Kimberley - 133 (24.9%).
- Midwest-Gascoyne region - 128 (24.0%); and
- Pilbara - 69 (12.9%).

In the year 2006 there was a total of 2,156 offences, of which 1,828 (84.8%) were possession offences and 328 (15.2%) were trafficking offences.

A breakdown of data for the North East Region by age group, which is counted on *processed persons*, shows that about three quarters of all drug offences involved persons aged between 15 and 34 years.

In the year 2006 there was a total of 1,977 processed persons (excluding cases where age is not known), of whom:

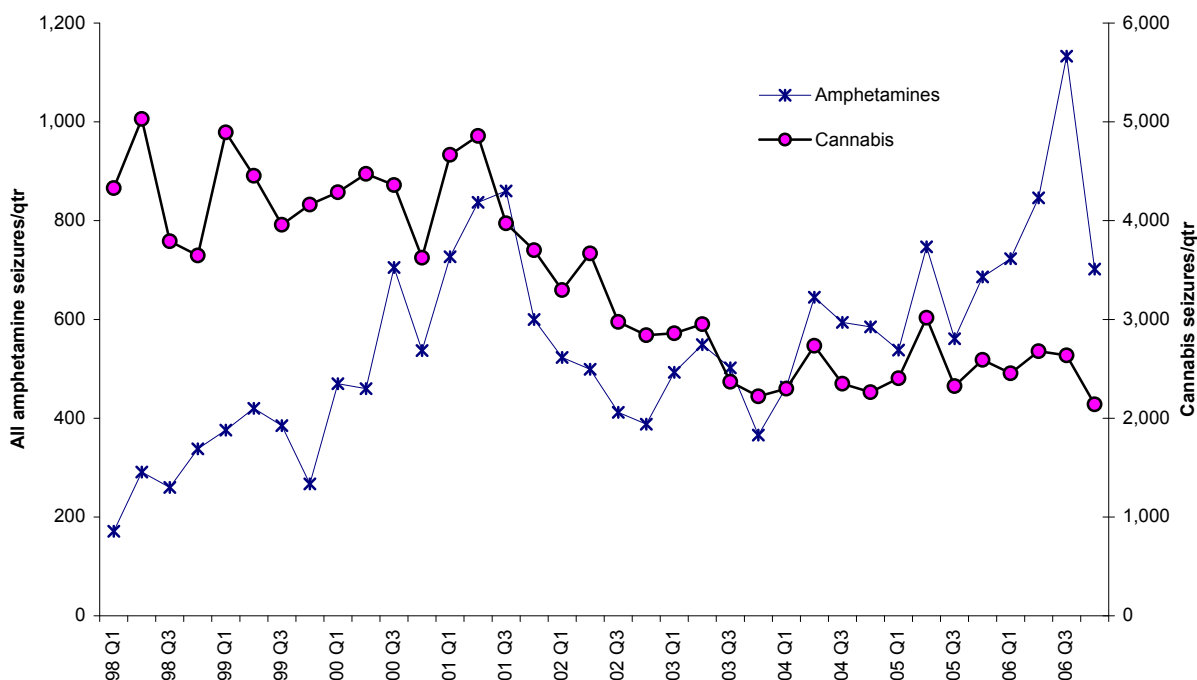
- 52 (2.6%) were aged less than 15 years;
- 316 (16.0%) were aged 15 to 19 years;
- 439 (22.2%) were aged 20 to 24 years;
- 647 (32.7%) were aged 25 to 34 years;
- 383 (19.4%) were aged 35 to 44 years; and
- 140 (7.1%) were aged 45 years and older.

## Drug Seizures: 1998-2006

### Annual trends

Table 2 (page 2) shows a marked decline from 1998 to 2006 of annual heroin seizures whereas seizures involving amphetamine type stimulants (ATS) (ie amphetamine and methylamphetamine) increased by about threefold.

Another notable trend has been a sharp decline in annual cannabis seizures since 2001, with about 10,000 seizures per year from 2003 to 2006, compared to about 17,000 seizures per year between 1998 and 2001.

From 1998 up to the present there has been a cyclical pattern in seizures involving ecstasy (MDMA), which increased from 190 in 1998 to 407 in 2001, then declined to 218 in 2002 and have since increased steadily, reaching 482 in 2006.

Total seizures of all drugs increased by 15.5%, from 19,962 in 1998 to 23,054 in 2000, fell by 41.2% to 13,558 in 2004 and then increased by 13.8% to 15,424 seizures in 2006.

The proportion of total seizures involving cannabis decreased over the nine year period, from 84.1% of all seizures in 1998 to 64.3% of all seizures in 2006.

### Quarterly trends

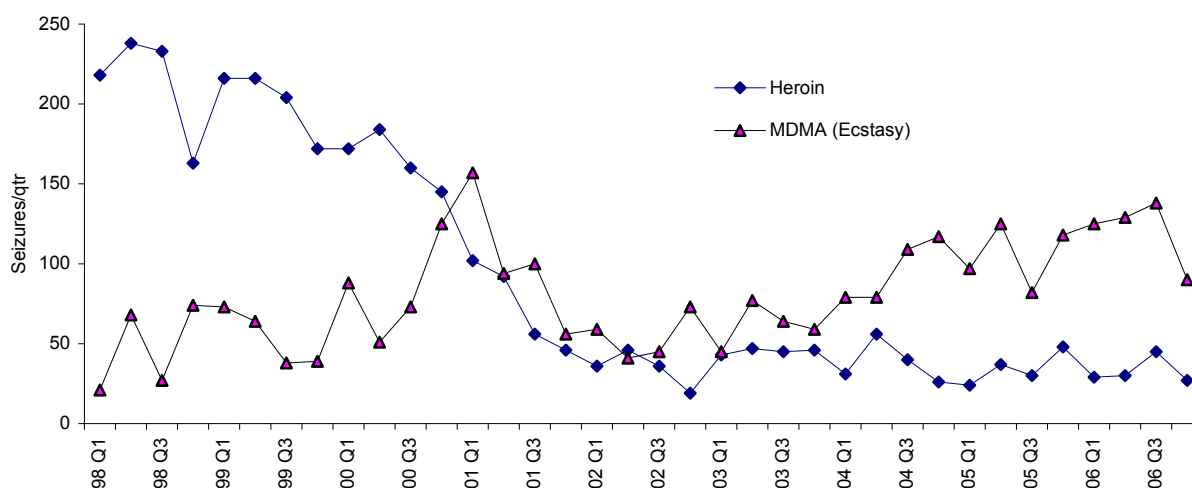
Figure 2 (page 3) shows the growing significance of ATS as a target of police activity over the period from 1998 to the present. Seizures of ATS increased from 171 in the March quarter 1998 to 860 in the September quarter 2001 and then decreased to 388 in the December quarter 2002.

There are different quarterly trends in seizures of cannabis and amphetamine type stimulants (Figure 2, page 3) compared to heroin and ecstasy (Figure 3).

Since 2002 there was a steady increase in ATS seizures to a peak of 1,133 seizures in the September quarter 2006 and subsequently there was a decline to 702 seizures in the December quarter 2006.

There was a long term trend of a decline in quarterly cannabis seizures from a peak of 5,029 in the June quarter 1998, dropping to 2,221 in the December quarter 2003. Throughout 2004, 2005 and 2006 quarterly cannabis seizures have remained relatively constant, with just under 2,500 seizures over the last three years.

Heroin seizures declined between 1998 and 2002 after which the number of seizures remained relatively stable. From the March quarter 1998 to the end of 2000 there was a greater number of heroin seizures than ecstasy, since mid 2002 ecstasy seizures have increased and exceeded quarterly heroin seizures (Figure 3).

## Methodology

This publication presents data for drug offences and drug seizures based on charges by the Western Australia Police and updates data previously published in:

- *Statistical Bulletin No. 9* (July 2000);
- *Statistical Bulletin No. 10* (February 2001);
- *Statistical Bulletin No. 12* (May 2001); and
- *Statistical Bulletin No. 16* (May 2005).

The data in this publication counts the number of charges involving offences under the *Misuse of Drugs Act 1981* where a person has been processed by the police. Information about charges is extracted from the Offence Information System (OIS) which records offences where a person has been processed. As data contained in this publication counts multiple offences, it does not provide a count of distinct persons.

Variations occur when comparing different tables, as breakdowns by age group are based on the count of processed persons, whereas breakdowns by offences as 'possession' and 'trafficking' are based on a count of offences. 'Processed persons' refers to adults as well as juveniles who have been arrested, summonsed, cautioned or appeared before a Juvenile Justice Team. This data does not measure court outcomes.

The cross tabulations of age group are based on the count of processed persons, whereas the breakdown of offences into 'possession' and 'trafficking' is based on a count of offences. As an offender may be charged with more than one offence there will be different counts of the total of drug offences for a quarterly period.

This data reflects police activity and accordingly deals with reported crime which has been detected and resulted in the apprehension of an offender. There are some difficulties in relation to interpretation of data from the seizure database, which is separate from the OIS. The data files for seizures are unstructured, lack uniform definitions and are unreliable as in some instances the type of drug seized cannot be readily identified. This also means that the type of drug cannot be readily determined in relation to each offence.

As there may be multiple seizures of drugs for each offence report, duplicate seizures have been removed so that the count of seizures is based on the most serious processed offence on a scale from -

- sell/supply (the most serious offence),
- cultivation,
- manufacture and
- possession/use (the least serious offence).

Offences are aggregated into two broad groups, 'possession' and 'trafficking'. 'Possession' refers to two types of offences, possession/use of drugs and possession of implements, both of which are simple offences and dealt with summarily in a Court of Petty Sessions.

The term 'trafficking' refers to the more serious offences of sell/supply, cultivation and manufacture which are usually dealt with in the higher courts.

Since 22 March 2004 infringements can be issued by police for the four expiable offences created by the cannabis infringement notice scheme (CIN) under the *Cannabis Control Act 2003*. These offences are possession of a smoking implement, possession of 15 grams or less of cannabis, possession of more than 15 and not more than 30 grams of cannabis and for non hydroponic cultivation of not more than two cannabis plants.

Cannabis infringement notices issued for any of these four offences, including cannabis seizures, are not recorded by the OIS.

It should be noted that the OIS does not accurately count the number of plants involving cannabis cultivation offences. This means it is not possible to determine the level of seriousness for this offence and accordingly offences concerning cultivation charges laid under the *Misuse of Drugs Act 1981* are included in the category of 'trafficking' offences, even though cultivation of less than 10 plants is a simple offence (*Misuse of Drugs Act 1981*, s. 7(2), Schedule VI).

Up to September 2000 police services in Western Australia were organised into 15 Police Districts (PDs), grouped into the Metropolitan Region and three country regions (Central Region, Southern Region and Northern Region).

Regional boundaries were revised in 1 July 2000, which took effect from 1 October 2000 and now police services are organised into 14 PDs, which are grouped into three regions, the Metropolitan Region, the Southern Region and North East Region, which are reported in this Bulletin.
