## Drug Related Telephone Calls, 1986 - 2005

### **Summary**

- There has been a shift in the composition of licit drug calls received by ADIS from 1986 to 2005 - tobacco related calls have steadily increased, prescribed drug related calls have declined since the early 1990s, whereas alcohol related calls, which were the most frequent licit drug call up to the mid 1990s, declined up to mid 2001 and have since increased.
- Cannabis related calls steadily grew up to mid 1999, then fell to mid 2002 and have since increased, whereas the most frequent number of designer drug related calls were from mid 1991 to mid 2000 and have since declined.
- There have been fluctuations in calls involving amphetamines, with three pronounced peaks in early 1995, at the end of 2000 and in mid 2004.
- Compared to the recent increase in amphetamine related calls, opioid related calls have fallen sharply since the period of high levels that occurred from early 1996 to late 1999, with some growth occurring in calls since 2001.

#### Introduction

The Alcohol and Drug Information Service (ADIS) is a 24 hour statewide service which may be contacted by phone 1800 198 024 (freecall) or 08 9442 5000. It was established in April 1986.


ADIS is operated by the Drug and Alcohol Office (DAO) and provides confidential counselling and referral on alcohol and other drug problems for drug users, relatives and friends of those with problematic drug use.

It operates in conjunction with the Parent Drug Information Service (PDIS), which was launched in October 1996 to provide specialist information, support, counselling and referral to key treatment and support services for parents concerned about drug use by their children.

## **All Drugs**

The number of quarterly calls for all drugs steadily increased from 899 calls in the June quarter 1986 to 3,993 calls in the March quarter 1995, then declined to 1,627 calls in the December quarter 2002 and has since increased to 3,065 calls in the December quarter 2005. See Figure 1.

The number of annual calls increased from 5,594 calls in 1987, the first full year of operation (ADIS commenced in March 1986) to a peak of 14,657 calls in 1995, then declined to 7,629 calls in 2002, then increased to 12,308 in 2004 and dropped slightly to 11,540 in 2005.

## **Licit Drugs**

Quarterly licit drug related calls increased from the 246 calls in the June quarter 1986 to 2,173 calls in the June quarter 1995 and then declined to a total of 839 calls in the December quarter 2002 and then has gradually increased to 1,765 calls in the December quarter 2005.

Though the relationship may not be evident in all circumstances, variations in the number of licit drug related calls over the period are considered to be related to public health campaigns, which have at different times targeted prescription drugs, alcohol and tobacco. For instance, there were peaks in mid 1989 and mid 1990 that are closely related to campaigns which targeted over prescribing of minor tranquillisers.

From the June quarter 1989 (599 calls) there was a steady decline in the number of quarterly prescribed drug calls up to the December quarter 2002 (90 calls), with some modest growth in calls from 2003 up to the present.

There was a gradual increase in the number of quarterly tobacco related calls from 1986 up to the June quarter 1998 (759 calls), declining to the December quarter 2001 (136 calls), increasing to the June quarter 2004 (688 calls) and

has since declined to 469 calls in the December quarter 2005.

Whilst alcohol related calls have been the most frequent licit drug call from the inception of ADIS up to present, there has been two broad trends in calls involving alcohol. See Figure 2.

## **Illicit Drugs**


There was an overall upward trend in the number of quarterly illicit drug related calls from 1986 to the March quarter 1995 (2,081 calls), followed by a gradual decline to the December quarter 2002 (788 calls) and has increased somewhat to 1,300 calls in the December quarter 2005.

A detailed breakdown of quarterly trends in designer drug, psychostimulant, opioid and cannabis related calls from 1986 to the present shows a number of features. See Figure 3.

The first feature is that there appears to be a synergy between the markets for heroin and psychostimulants as there is an inverse relationship of calls involving opioids and psychostimulants. This may indicate that one drug is a substitute for the other according to availability of supply and preferences.

The second feature is that there has been a cyclical variation in psychostimulant calls and that calls involving this drug have become the most frequent type of illicit drug related call since the beginning of 2000.

The third feature is that from 1995 to 1999 there was a greater number of quarterly calls involving cannabis compared to the period 2000 to 2005 and that up until the end of 1999 calls involving cannabis exceeded calls involving psychostimulants.

#### **Cannabis**

Quarterly cannabis related calls increased by more than two fold from 203 calls in the June quarter 1986 to 692 calls in the September quarter 1995, declined to 300 calls in the December quarter 2002 and then increased to 573 calls in the September quarter 2004. Calls have since declined to 451 by the December quarter 2005.

## **Designer Drugs**

Quarterly designer drug related calls have fluctuated markedly over the period from 1986 up to the present. There were peaks in the September quarter 1992 (189 calls), March quarter 1995 (217 calls) and the March quarter 2000 (182 calls). Since 2001 there have been about 50 and 75 calls per quarter.

## **Psychostimulants**

There have been marked cyclical variations in quarterly psychostimulant calls received from 1986.

Quarterly psychostimulant related calls increased from 36 calls in the the September quarter 1986 to 711 calls in the March quarter 1995, then decreased by nearly two thirds to 177 calls in the June quarter 1996 and then increased to 851 calls in the December quarter 2000.


After the December quarter 2000 calls fell to 357 calls in the December quarter 2002, then increased up to 712 calls in the December quarter 2004 and then after a further decline reached 661 in the December quarter 2005.

## **Opioids**

Quarterly opioid related calls have fluctuated from 1986 up to mid 1993, with about 150 to 200 opioid related calls per quarter. The number of calls increased by just over four fold from 215 calls in the March quarter 1993 to 852 calls in the September quarter 1997, dropped to 655 calls in the September quarter 1998.

Calls increased from the September quarter 1998 to 831 calls in the September quarter 1999, then dropped markedly to 122 calls in the September quarter 2001. Since the September quarter 2001 opioid related calls have increased somewhat to 283 calls in the December quarter 2005.

Figure A-1 Quarterly psychostimulant, opioid, cannabis & designer drug related telephone calls, March 1986 - December 2005




Figure A-2 Annual calls - designer drugs, other drugs, prescribed drugs & tobacco, 1986-2005




Figure A-3 Quarterly alcohol, tobacco and prescribed drug related telephone calls, March 1986 - December 2005




Figure A-4 Quarterly cannabis related telephone calls, March 1986 - December 2005




Figure A-5 Quarterly designer drug related telephone calls, March 1986 - December 2005




Figure A-6 Quarterly psychostimulant related telephone calls, March 1986 - December 2005




## Methodology

Non identifying data are routinely collected for each call, such as the type of drug mentioned, type of caller, age and sex of caller, caller's postcode of residence and outcome of the call. The data contained in this publication has been extracted from monthly reports on the number of drug related telephone calls received by ADIS and PDIS.

Since the inception of ADIS in March 1986 there has been a number of enhancements in data collection which determine the level of detail available. Enhancements in 1996 and at the end of August 1999 provide improved information about additional drugs. It should be noted that as data were not collected for some specific drugs in the period 1986 to 1995, these calls were recorded as 'other drugs'.

This publication contains data for calls where the primary drug of concern was either alcohol, tobacco, cannabis, opioids (eg heroin, narcotic analgesics, methadone & non narcotic analgesics), designer drugs (eg hallucinogens, ecstasy and LSD), psychostimulants (eg amphetamines, methamphetamines, dexamphetamine and cocaine), other drugs (eg volatile substances, anabolic steroids, polydrug abuse, opioid abstinence and alcohol abstinence) and prescribed drugs (eg major tranquillisers, minor tranquillisers and anti-depressants). The report also presents aggregate data for three broad groups:

- licit drugs (eg alcohol, tobacco, narcotic analgesics, non narcotic analgesics, methadone, buprenorphine, prescribed drugs);
- illicit drugs (cannabis, heroin, morphine, codeine, dextromoramide, designer drugs, psychostimulants, volatile substances, steroids, polydrug use and unspecified drugs); and
- all drugs (licit drugs and illicit drugs).

Note: The totals in this publication do not reflect annual total of all calls, as ADIS also receives non user and information calls, which do not involve current drug use.
